### 1. New water rates are as follows:

.006 0 - 10,000 .0075 10,001 - 18,000 .0125 18,001 - 30,000 .0150 30,001 - and up

These rates will be put into effect December 1, 2021.

### 2. Booster Pumps

We have 2 booster pumps that build the pressure in the pressure tank that sends water from the pressure tank to you.

These boosters are very old and will need to be replaced soon. The financial committee suggested we go ahead and purchase these boosters now and have them for when we really need them. This suggestion came

to be due to rising costs.

#### 3. Shut off Valves

We need to purchase a tool called a valve exerciser to exercise the valves. This is very important to keep them working correctly.

We also need to put 4 shut off valves (possibly not 4 but I'm covering the bases). These will be put in specific spots to where they will be able to shut down specific water lines for repair.

## 4. Financial for upcoming repairs and replacements

Right now we have the funds to take care of a lot of the things we have been talking about.

The Checking Account as of today, November 1, 2021 \$22,856

The Savings Account as of today, November 1, 2021 \$10,338

The booster pumps might cost \$5000 plus labor to install.

The valve exerciser might cost around \$40.

The ball valves that we will purchase might cost \$100 per valve.

Our maintenance committee will let us know ASAP so that we have a better idea of the cost. We are wanting to get these materials before the end of the year.

### FINANCIALS CONCERNING THE USDA LOAN

We discussed paying off the loan or at least a great deal of it before the end of the year. By doing this we will not be double taxed.
